RESOLUTION OF THE LOCAL AGENCY FORMATION COMMISSION OF THE DETERMINING THAT THE SAN DIEGO COUNTY WATER AUTHORITY IS NOT A "DISTRICT" WITHIN THE MEANING OF THE DISTRICT REORGANIZATION ACT OF 1965

On motion of Commissioner Chapman , seconded by Commissioner Gorton , the following resolution is adopted:

WHEREAS, pursuant to Government Code Sections 56039 (m), 56015 and 56016, the Board of Directors of the San Diego County Water Authority on November 11, 1976, adopted Resolution No. 76-50 making application to the Local Agency Formation Commission requesting a determination that the Authority is not a "District" within the meaning of the District Reorganization Act of 1965; and

WHEREAS, the Acting Executive Officer of this Commission gave the Board of Directors of the San Diego County Water Authority mailed notice of the time and place at which such application would be presented to this Commission, as required by Government Code Section 56015; and

WHEREAS, the application was presented to the Commission at its December 6, 1976 regular meeting; NOW THEREFORE

IT IS RESOLVED, FOUND, ORDERED AND DETERMINED as follows:

- l. The San Diego County Water Authority is a county water authority formed pursuant to the County Water Authority Act (Stats. 1943, Ch. 545), and is situated within the County of San Diego.
- 2. The Commission finds that the San Diego County Water Authority is not engaged:
  - (a) In the distribution and sale for any purpose other than for the purpose of resale, of water or of gas. or electricity for light, heat or power;
    - (b) In furnishing sanitary sewer service or garbage and refuse collection service to the ultimate users thereof:
      - (c) In providing fire or police protection; or
    - (d) In the acquisition, construction, maintenance, lighting or operation of streets and highways, street and highway improvements or park and recreation facilities, except as an incident to the exercise of other lawful powers of the Authority.

The Commission determines that the San Diego County Water Authority is an authority enumerated in subdivision (m) of Section 56039 of the Government Code, that the San Diego County Water Authority is not a "district" within the meaning of Division 1, Title 6 of said Government Code (the District Reorganization Act of 1965), that none of the provisions of said Division shall apply to the changes of organization of the San Diego County Water Authority and that proceedings for such changes of organization shall be taken under and pursuant to the principal act of the Authority, to wit: The County Water Authority Act.
- 4. The Clerk of the Commission is directed to transmit a certified copy of this resolution to the San Diego County Water Authority.
